All applications will be reviewed for approval by the National Association of REALTORS® at the mid-year meeting or the Annual Conference. The dues waiver does not take effect until the following 'dues season'. For example, members approved as Emeritus at the NAR Mid-Year or Annual meetings in 2018 would have their National and State dues waived starting in 2019.

**Emeritus members are still responsible for paying the local dues annually.** Upon approval, each REALTOR® Emeritus member will receive a congratulatory letter, certificate and 40-year REALTOR® Emeritus lapel pin. If you believe that you fulfill the requirements to achieve REALTOR® Emeritus status as defined above and would like to have all future national and state dues waived, please download and submit the REALTOR® Emeritus application.
